Allen, Gibbs & Houlik, L.C. Named in 2011 Top 100 Best Accounting Firms to Work For

(WICHITA, KAN.) – Based on feedback from its employees and a summary of the firm’s policies, practices and employee benefits, Wichita CPA and advisory firm Allen, Gibbs & Houlik, L.C. (AGH) was recently named one of the 2011 *Best Accounting Firms to Work for*.

The annual list of “Best Accounting Firms,” created by *Accounting Today* and Best Companies Group, surveys accounting firms nationwide to honor the best places of employment in the accounting industry. AGH’s placement in the awards means it ranked as **one of the top 45 medium-sized CPA firms in the US as a place to work.**

“This honor is especially meaningful for AGH because of the input from our staff,” says chief executive Paul Allen. “It’s a recognition that AGH and this community can offer challenging and satisfying careers for a lifetime here in the Midwest.” AGH had earned similar recognition at the local level in the Wichita Business Journal Best Places to Work awards for four different years.

Accounting firms across the country entered the two-part survey process to determine the *Best Accounting Firms to Work for*. The first survey evaluated each firm’s workplace policies, practices, philosophy, systems and demographics. The second survey asked for firm employees’ input to measure the employee experience. The combined scores determined the top firms and the final ranking. Best Companies Group managed the overall registration, survey and analysis process and determined the final rankings for the 100 total companies, split into three groups by number of employees: 50 small companies (15-49 employees), 45 medium companies (50-249 employees) and 5 large companies (more than 250 employees).

Winning firms in the 4th annual *Best Accounting Firms to Work for Awards* will be honored at a ceremony Oct. 25-27 at *Accounting Today’s* 2nd Annual Growth & Profitability Summit. The list-making firms will also be published in the December issue of *Accounting Today*.
